8/16/93: Drllg. TD 12-1/4" hole at 4035'. RU and begin running 8-5/8" casing string.

8/17/93: Ran total of 89 jts 8-5/8" 32# J-55 casing and set at 4035'. Cemented w/ 1250 sx "C" Lite + 9 pps salt & 1/4 pps Celloseal. Tail w/ 500 sx C1 "C" + 2% CaCl₂. Plug down at 3:15 a.m. Circ'd 150 sx to pits. WOC. Cut off and weld on 8-5/8" x 11" 3M head. NU BOPs. Test to 3000 psi. Test Hydril to 1500 psi, ok.

8/18/93: PU BHA and TIH. Test casing to 1500 psi, ok. WOC total of 24 hours. Resume drilling operations.
