8/24/93: TD 8050'. RU and ran 183 jts 5-1/2" 15.5# & 17.0# K-55 and J-55 LT&C casing and set at 8050'. Stage tool @ 5950'. Cemented 1st stage w/ 475 sx C1 "H" containing .8% FL-25 and 5% KCl. Open stage tool and circ (137 sx circulated to pit). Cemented 2nd stage w/ 100 sx C-Lite. Tail w/400 sx C-Neat. Plug down at 2:45 p.m. CST. ND and set slips w/ 110,000#. Cut off 5-1/2" casing and install tubing head. Test head to 3000 psi, ok. Released rig at 7:00 p.m. CST. WOCU.
