6/8/93: Depth 4200'. RU and ran 93 jts 8-5/8" 32# K-55 casing and set at 4197'. Cemented w/ 1300 sx PSL 35:65 containing 9 pps salt and 1/4 pps Celloseal. Tail w/ 500 sx C1 "C" + 2% CaCl<sub>2</sub>. Plug down at 5:30 p.m. Circ 230 sx to pit. WOC.

6/9/93: Cut off and weld on 8-5/8" head. Test weld to 550#, ok. NU and test BOPs and manifold to 3000 psi, Hydril to 1500 psi, ok. RU DC and GIH.

6/10/93: PU BHA and TIH. Test casing to 1500 psi, ok. Resume drilling operations.
