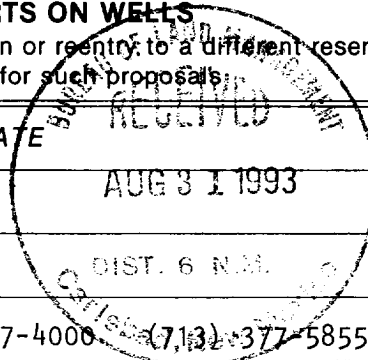

Cmtd w/350 sx Class C + 4% gel + 2% CaCl₂ + 1/4#/sx CF (1.74 ft³/sx, 13.5 ppg) and 200 sx Class C + 2% CaCl₂ (1.32 ft³/sx, 14.8 ppg). PD @ 1830 hrs 8/17/93 w/650 psi. Circ 114 sx cmt to surf. WOC.
