POOH w/2-3/8" tubing and 7" PermaLatch packer at 11,744' laying down tubing.

Set CIBP and 35' of cement at 11,770' then perforate Wolfcamp (11,092-11,120').

MIRU BJ and frac Wolfcamp with 75,000#± Carbo-Prop 20/40 down rental string.

POOH with rental string and RIH with completion string, rods and pump.

Install pumping unit and produce the Wolfcamp interval.
