We spud this new well on 9/14/93 at 1815 hours. On 9/16/93, we set 855' of 13 3/8" surface casing in a 17 1/2" open hole. The casing was cemented with the following cement slurries:

500 sx Lite (35:65) + 6% gel + 2% CaCl₂ + 1/4 lb/sk cellophane flakes

200 sx Class "C" + 2% CaCl₂ + 1/4 lb/sk cellophane flakes

The cement was circulated to surface (104 sx).
