On 10-4-93, we reached TD and ran 8400' of 5 1/2" production casing in a 7 7/8" open hole. The casing was cemented in two stages with a DV tool set at 5865'. We ran the following cement systems:

1st Stage = 500 sx Silica Lite + 3% salt + 0.6% fluid loss additive + 0.3% dispersant + 0.2% free water control + 1/4 lb/sk cellophane flakes
(Slurry weight = 13.6 ppg, slurry yield = 1.82 cft/sk)

2nd Stage = 250 sx LITE (35:65) + 6% gel + 1/4 lb/sk cellophane flakes
(Slurry weight = 12.7 ppg, slurry yield = 1.88 cft/sk)
400 sx Class "C" + 4% gel + 5 lb/sk salt + 1/4 lb/sk cellophane flakes
(Slurry weight = 13.6 ppg, slurry yield = 1.70 cft/sk)

We circulated 110 sx of cement to the pit on the 1st stage. Estimated TOC = 2500'.
