At 2400 hrs on 12-8-93, we spud this new well. On 12-10-93, we TD'd the 17 1/2" hole at 860'. We ran 860' of 13 3/8" surface casing and cemented to surface with the following cement slurries:

200 sx LITE (35:65) + 6% gel
(slurry wt = 12.7 ppg, slurry yld = 1.88 cft/sk)

400 sx Class "C" + 4% gel + 5 lb/sk salt
(slurry wt = 13.6 ppg, slurry yld = 1.69 cft/sk)

125 sx Class "C" + 2% CaCl2
(slurry wt = 14.8 ppg, slurry yld = 1.32 cft/sk)

We circulated 100 sx to surface.
