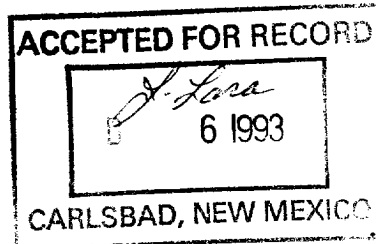
13. Describe Proposed or Completed Operations (Clearly state all pertinent details, and give pertinent dates, including estimated date of starting any proposed work. If well is directionally drilled, give subsurface locations and measured and true vertical depths for all markers and zones pertinent to this work.)

On 11/11/93, we set 4140' of 8 5/8", 32 ppf intermediate casing in an 11" open hole.
The casing was cemented to surface using the following cement slurries:

1150 sx LITE (35:65) + 6% gel + 15 lb/sk salt + 1/4 lb/sk cellophane flakes
(slurry weight = 12.7 ppg, slurry yield = 2.0 cft/sk)

200 sx Class "C" + 2% CaCl₂ + 1/4 lb/sk cellophane flakes
(slurry weight = 14.8 ppg, slurry yield = 1.32 cft/sk)

We circulated 110 sx of cement to surface.

GENERAL INSTRUCTIONS

This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
