On 8/30/94, we ran 8 5/8" casing as follows: Shoe @ 4099', Float Collar @ 4011', 6 centralizers at 4057', 3924', 3806', 3679', 3540', & 3401', 95 jts of 8 5/8", 32 ppf, J-55, 8rd STC csg. The casing was cemented as follows by Dowell Schlumberger:

1300 sxs 35/65 POZ C + 6% gel + 15 #/sk salt and 1/4#/sk celloflake.
200 sxs C + 2% CaCl and 1/4#/sx celloflake.

We circulated 262 sx cement to surface.
