7/9/94: Depth 420'. RU and ran 10 jts 13-3/8" 48# H-40 ST&C casing and set at 420'. Cemented w/ 100 sx C1 "C" Lite containing 6% gel, 1/4 pps Flocele, & 2% CaCl₂. Tail w/ 225 sx C1 "C" + 2% CaCl₂. Plug down @ 4:30 a.m. MST. Circ'd 50 sx to pit. WOC. NU head & Hydril.

7/10/94: WOC. TIH and test casing to 600 psi, ok. WOC total of 24 hours. Resume drilling operations.
