Propose to abandon Atoka and Morrow and recomplete to Wolfcamp as follows:

1. Load tubing and casing with 2% KCL water.
2. Nipple down tree and nipple up BOP.
3. POOH with tubing and Baker Model K-36 anchor seal assembly.
4. Set CIBP's at 13550' to abandon Morrow and at 12800' to abandon Atoka. Cap each CIBP with 35' of cement.
5. GIH with Baker retainer production packer on wireline and set packer at 11850'.
6. GIH with seal assembly, 1 joint of 2-3/8" tubing, "F" nipple, 2-3/8" tubing to top of liner and 2-7/8" tubing to surface.
7. Sting into packer, space out and pressure test. Nipple down BOP & nipple up tree.
8. Swab tubing down to 10500'±.
9. Perforate 11914-11942' (Wolfcamp) with thru tubing guns, acidize as necessary for production.
10. Swab/flow test.
11. Place well into production.
