Santa Fe Energy Operating Partners, L.P. proposes to implement the following changes to drill the captioned well.

1. We propose to set 13-3/8" 48# casing in a 17-1/2" hole at 400', utilizing 400 sx of cement to circulate.
2. We propose to drill an 11" hole to $\pm 4200'$ (instead of the stated 12-1/4" hole).
3. We propose to test the 3-M BOP stack and manifold to 1500 psi with a rig pump.
