Propose to commingle perforations 7368-7543' (Cisco) and 8671-9178' (Strawn) as follows:

1. Load tubing. Nipple down tree and nipple up BOP.
2. Unset packer and 7328'.
3. GIH to RBP at 7588', latch onto RBP. TOOH with tubing, packer and RBP.
4. GIH with packer with on/off tool and 1.875" profile nipple. Set packer at 7328' and pressure test.
5. Nipple down BOP and nipple up tree.
6. Swab well in.
7. Place well into production.
