Perforate the Delaware from 7350'-7558' with 6" SPF and 60 degree phasing. RIH with 2 7/8" WS and set frac packer at approximately 7150'. Frac Delaware with 100,000# sand. POOH with 2 7/8" WS. RIH with 2 7/8" completion string and rods. Production test new Delaware interval on pump. Within 30-60 days, POOH with rods and tubing. Drill out composite BP at 7540'. RIH with 2 7/8" completion string and rods. Complete all open Delaware intervals.
