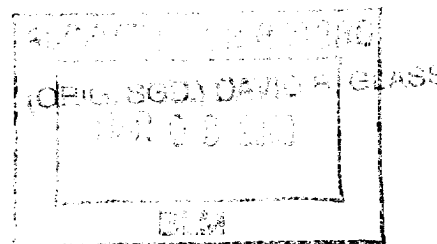

IFV @ 609'. BJ cmt'd csg w/ 450 sxs Cl "C" 35:65 POZ @ 12.8 ppg followed by 200 sxs Cl "C" + 2% CaCl2 @ 14.8 ppg. Circ 150 sxs. Plug down @ 1630 hrs CST 02/27/00. WOC 30 hrs. Make cut-off. Weld on WH. NU BOP's & test to 1000# ok.
