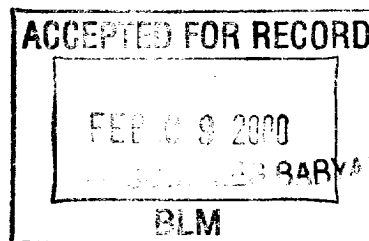

2nd stage, cemented with 410 sx 50/50 Poz C with additives. Tail with 100 sacks Class C Neat. No cement circulated. Duncan Whitlock notified @ 3:00 a.m. on 1/23/00 of not circulating cement and tagging at OK'd topout. Top out with 25 sx Class C, circulated 10 sx to surface.
