Ran 18 joints 5-1/2", 17#, L-80, LTC (7076-7754'), 22 joints 5-1/2", 17#, L/S LTC (5577-7076'), 140 joints 5-1/2", 15.50# J-55 LTC (0-5577').

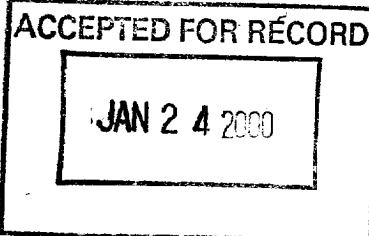
1st stage, cemented with 400 sx Super H modified with additives. Circulate 70 sx, estimated TOC @ 5400'.

2nd stage, cemented with 450 sx 50/50 Poz C with additives. Tail with 100 sacks Class C Neat. Did not circulate cement. Lost returns.

WOC 9.75 hours. Ran temperature survey. TOC @ 420'. PU 3/4" pipe, could not work past 104', collar wouldn't pass centralizer. Pump 43 sacks Class C Neat to top out at 104'. Calculated base of cement at 212'.

Test wellhead to 3000 psi, OK. Release rig at 1:00 p.m. 1/9/00.

Test for completion.
