3. Drill 9 7/8" hole to 2900'. Run and set 2900' of 7 5/8" 26.4# J-55 ST&C casing. Cement with 900 Sx. of Class "C" cement + additives, Circulate cement to surface.
4. Drill 6 3/4" hole to 7100'. Run and set 7100' of 4 1/2" 11.6# J-55 casing. Cement in two stages DV tool at 5550'±. Cement with 1000 Sx. of Class "H" cement + additives. Estimate top of cement 1900'.

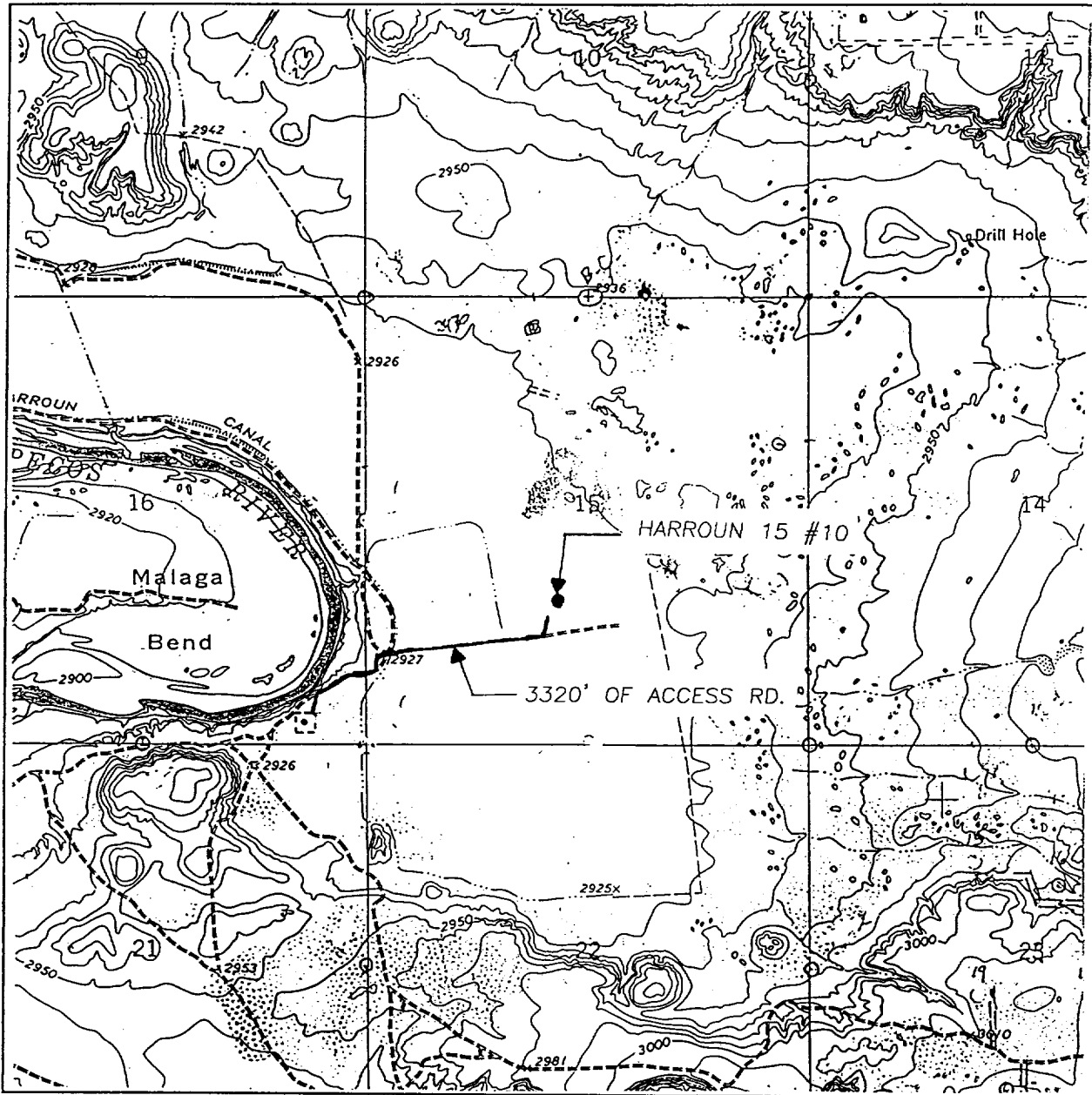

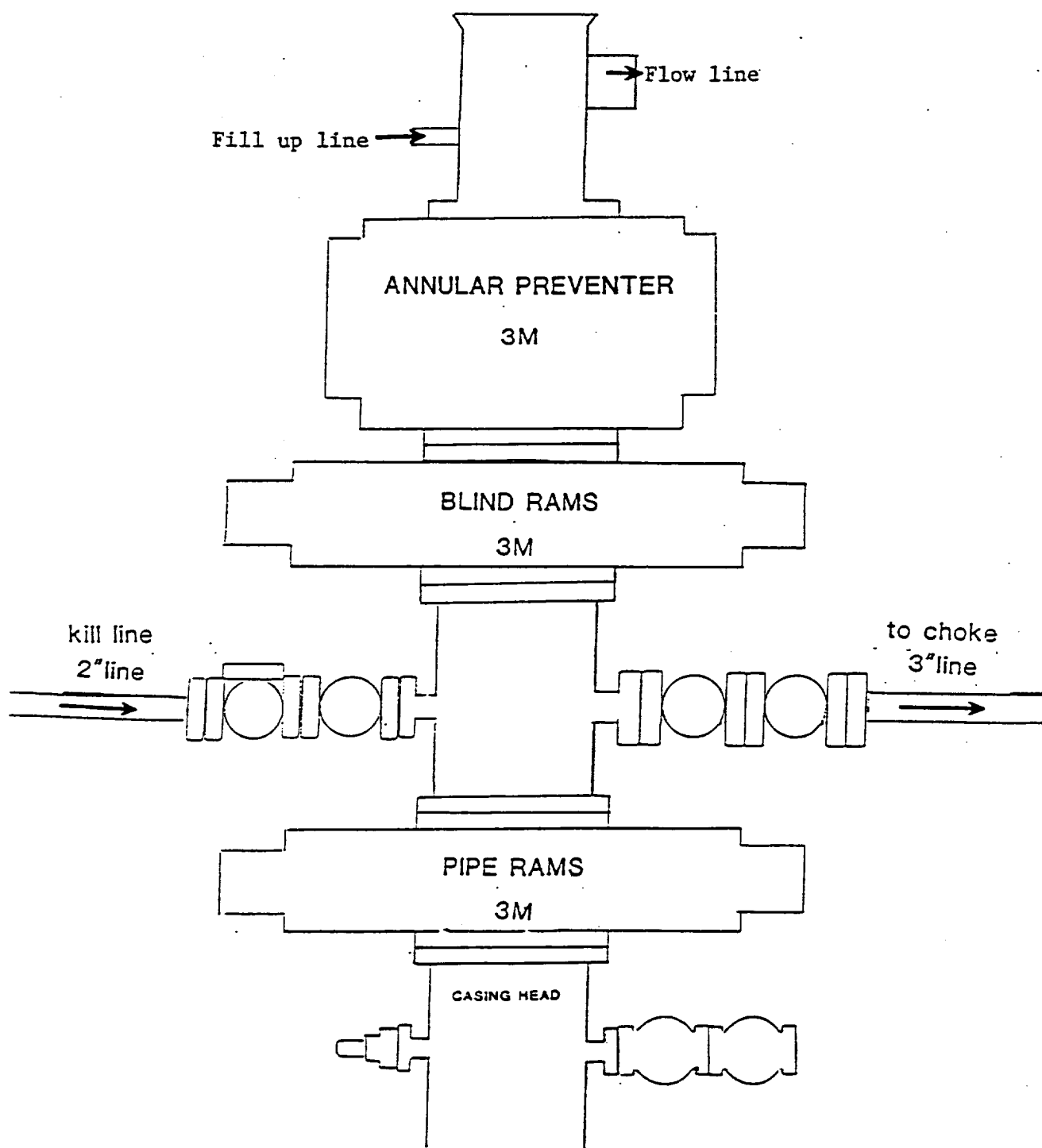

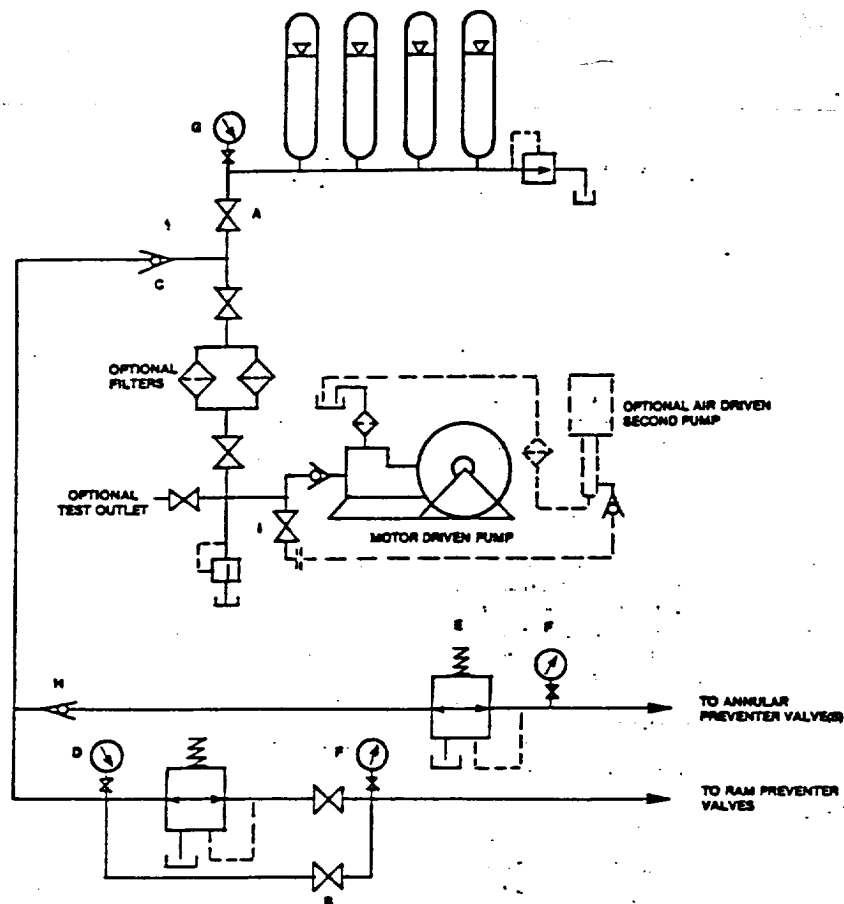
