DETAILS OF WORK

We propose to drill this well to approximately 2200 feet in the Delaware Sand formation using rotary drilling equipment. Our casing program is as follows:

Drill 11" hole to approximately 250 feet where 8-5/8" 24# J-55 casing will be set using enough cement to circulate.

Drill out 7-7/8" hole below surface casing to Total Depth where 3-1/2" 15.5# J-55 casing will be set using approximately 200 sacks cement.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

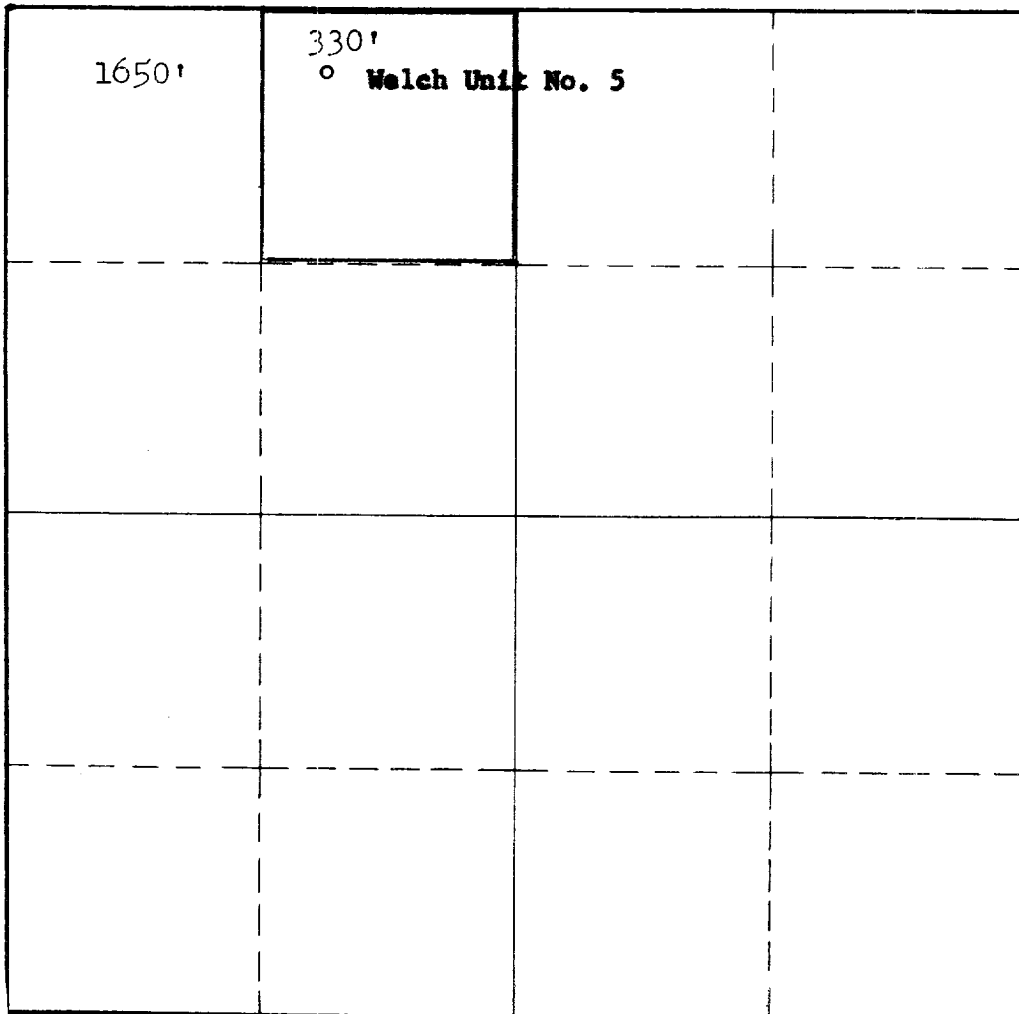
