Sand-traced w/500 gals 15% HCl acid, 2000 gals galloil oil, 3000# 20-40 sand. Opened wells up after 24 hrs. Well producing 39 bbls oil, 13 bbls water per day. 10/64 choke, 225# tubing pressure. First production October 25, 1962.
