Ran 97 Jts (4061') 5-1/2" OD 15.50# Gr J-55 SS casing. Set and cemented at 4075' with 200 sacks 45 Gal and 200 sacks Neat on bottom. Plug at 3990'. Maximum pressure 800#. Job complete 9:30AM 3-14-55.

After waiting over 30 hours, tested 5-1/2" casing with bailer for 2 hours. There was no fluid. Drilled cement plug from 3990' to 4075'. Bail tested cement 3 hours. No fluid recovery.
