- 1> RU & attempt to kill well by pumping into Morrow. Could not pump in @ 1400 psi. Annulus had 0 psi during pump - in.
2> Shoot 1/2" hole in 2 7/8" @ 6297'. Circulate & kill well w/9#gal brine.
3> Attempt POH w/tbg - parted @ ± 1600' - Attempt to fish.
4> Attempt load hole. Believe to be loosing fluid @ ± 4100' - 4800'. The 5 1/2 8 5/8 annulus blowing gas. Casing is parted @ ± 1640'.
5> Continue to try to load hole. Not successful.
6> Continue to try to recover tubing, tie casing together. Not able to load hole, kill well or recover fish.
7> Shut down & request approval to plug and abandon.
