Notice is hereby given of our intention to recomplete the BR 4 Federal No. 3 that was originally drilled as an oil well. The well was originally perforated from 1340 - 1341 W/2 jet shots per foot and acidized W/500 gallons acid, 2,000 gallons oil and 3,000 pounds sand. After considerable testing well did not prove out as an oil well, however throughout the testing the well made approximately 17 barrels water per day w/trace of oil and approximately 200 MCFPD. It is our intention to blank out the perforations from 1340 - 1341 with a blanking plug and then perforate the interval from 1331 to 1335 W/2 jet shots per foot. The well will then be treated with 500 gallons Dowell BDA and testing will commence.
