Notified Mr. Shannon Shaw w/BLM of re-entry 11-28-94. RU unit. Cut off 8 5/8" csg & dry hole marker. Weld on new 8 5/8" csg stub & 8 5/8" x 11" 3000# psi. Wellhead, test to 500 psi, OK 11-28-94.

Ran in hole w/7 7/8" bit to 509'. Drill out plug & cmt. Tst to 600 psi, OK 11-29-94. Drilled plug #2 @ 2290'. Wash & reamed to plug #3 @ 4059'. Drilled cement & washed to old TD @ 4481'. Drill new hole to 4995' 12-3-94.

Ran 115 jts 5 1/2" 15.5# K-55 LT&C csg. Set @ 4995' 12-4-94. DV tool @ 3687'. Cemented in 2 stages. Stage #1 w/520 sx Class C w/additives. Circ 53 sx off DV tool to surface. Stage #2 w/1150 sx P.S.L. & Class C w/additives.

Circ 117 sx cement to surface. WOC 30 1/2 hrs. PBTD @ 4904'. 12-6-94 RIH w/4 3/4" bit. Tagged TOC @ 3590'. Drilled cement & DVT. Tested csg & DVT to 2000 psi for 30 min, OK. Circ to clean out. Release unit. Prep for completion.

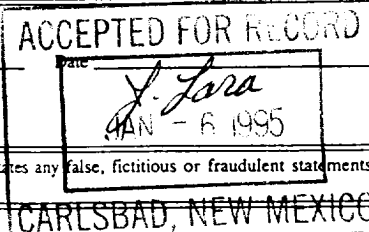
