Because both strings were cemented to the surface, an adequate plugging program will be a 150' plug at bottom, 100' intermediate plug, and the top plug at 100'. The date of plugging will be selected after arranging for cementing and other equipment.

The Bureau of Land Management will be given at least one day notice by telephone prior to plugging.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

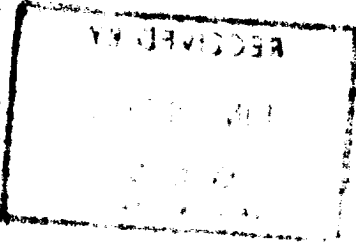

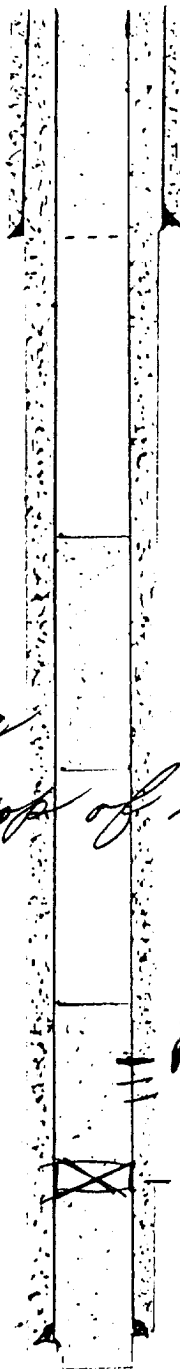
