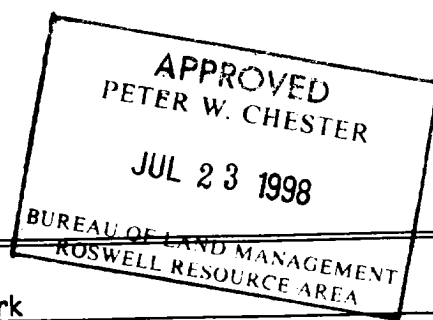

- 1) Set 1st CIBP @ +/-14,810'. Dump bail ³⁵ 30' Class H Neat cement on top of CIBP.
- 2) Set 2nd CIBP @ +/-14,100'. Dump bail ³⁵ 30' Class H Neat cement on top of CIBP.
- 3) Test casing/CIBP to 2000 psi.
- 4) RIH w/ casing gun loaded with 2 JSPF with 180 degree phasing and perforate the following interval:
12,896-12,944' (53 holes)
- 5) Acidize with 5000 gallons of 20% HCl acid with additives.
- 6) Return well to production.
