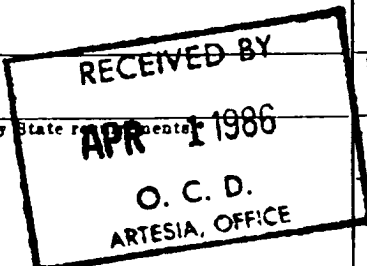

T.D, 12,900' Shale, PBTD 2134'. After receiving verbal approval for the following plugging procedure this well was plugged and abandoned in the following manner:

1. Loaded hole w/mud laden fluid and set a CIBP @ 2080' and dumped 9 sacks (35') of cement on top of CIBP @ 2080 - 2045'.
2. Cut off 7-5/8" casing @ 1408' and POOH w/casing. RIH w/2-7/8" OE'd tubing and spotted a 50 sack Class C cement plug @ 1450 - 1350', 1/2 in and 1/2 out of the 7-5/8" casing stub @ 1408'. POOH w/tubing.
3. RIH w/2-7/8" tubing and tagged cement plug @ 1300'. POOH w/tubing.
4. Cut off WH and dumped a 10 sack cement surface plug @ 20 - surface. Installed a 4" dry hole marker to designate a plugged and abandoned location.

This well was plugged and abandoned on 5-10-83.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
