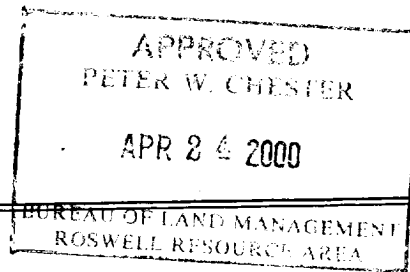

1. MIRU about April 25, 2000. Set CIBP at 5010' w/4 sx cmt on top (with dump bailer).
2. Set cmt retainer at 3800'. Cmt squeeze perforations 3918-4024'. Pump 5 sx cmt on top of cmt retainer thru tbq.
3. Shoot 4 way squeeze holes at 600'. Circulate cmt out squeeze holes at 600' back to surface between 5 1/2" csg and 8 5/8" csg. Leave 5 1/2" csg full of cmt.
4. Cut csg off below plow depth and erect P&A marker.
