4-26-2000: Set cmt retainer @ 3787'. Squeeze perforations 3918-4024' w/150 sx cmt. Dumped 65' of cmt on top of retainer.

4-27-2000: Perforate 4 holes in 5 1/2" csg @ 600-601'. Circulated 190 sx down 5 1/2" csg out perforations @ 600-601' and back to surface between 5 1/2" and 8 5/8" annulus. Cmt inside of 5 1/2" csg is 190' from surface.

4-28-2000: Cut off bradenhead, put cmt plug inside 5 1/2" csg from 5' to 35' down. Weld 1/2" steel plate in top of 8 5/8" collar. Erect P&A marker. Cleaned up location.
