Due to this well making a high volume of water, and gas is to small to measure (Conoco has pulled their meter), Claco Oil Company respectfully requests permission to Temporarily Abandon this well for a period of one (1) year. This will enable us to fully evaluate for workover and/or re-compleat potential. A casing integrity test will be performed and recorded on a chart---500 psi for 30 minutes.
