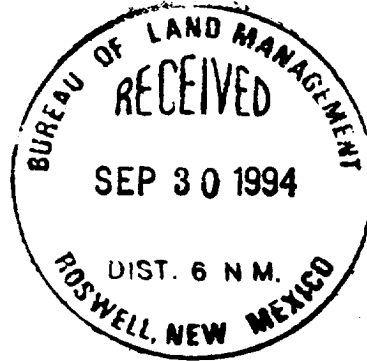
1. RIG with bit & scraper and tag bottom @ 6730'.
2. Perforate from 6278' - 6298' and 6084' - 6104' with 2 SPF (84 holes total).
3. Treat interval 6278' - 6298' with 1000 gal.s acid.
4. Treat interval 6084' - 6104' with 1250 gal.s acid.
5. RIH with tubing, rods & pump and put well on production.
