Drilling without returns TD @ 487' @ 16:00, TOH RIH with 11 Jts 8 5/8", 24# casing with Texas pattern shoe, float insert and 2 centralizers (Middle 1st joint., Top 3rd joint) - set at 485', cement with 75 sx 65/35 pozmix + 2% CaCl₂ + 1/4 #/sk celloflake - followed by 200 sx C + 2% CaCl₂ + 1/4#/sk celloflake - No returns - RIH with 1" string and tag annular fill up at 121' - Dump 5 cubic ft., 3/8" pea gravel down annulus, cement down 1" string with 75 sx "A" + 3% CaCl₂ - No fillup, Dump 5 cubic ft. 3/8" pea gravel, RIH with 1" string - cement with 188 sx A + 4% CaCl₂ got cement to surface.

1-23-87 Drill shoe & 7 7/8' new hole, 3/4° @ 969'. Drilling @ 1050'.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
