Ran 106 joints of 5 1/2" 15.5 #/ft J-55 LTC casing @ 5067'. Float shoe 5067', float collar 5022', stage tool 3230'. Cement first stage w/ 280 sx Class A + 10% salt and 10% Gypsum + 1/4 #/sk celloflake w/ 420 gallons mud-wash ahead, bump plug 600 psi over displacement pressure, float held. Dropped stage tool opening bomb, opened tool and circulated for 5 hours. Cement second stage w/ 200 sx 65/35 pozmix + 5% gel + 10% salt and 1/4 #/sk celloflake, displace with water, bump stage tool closing plug to 2200 psi over displacement pressure, tool closed. Hung csg in slips, weld on bell nipple. Rig released 18:30, 02-04-87.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
