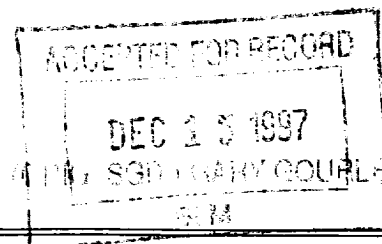

Well has not been plugged as yet.

Work-over for production in the Lower Cherry Canyon sand and in the Getty sand, Brushy Canyon. Getty sand from 5970-6000', Lower Cherry Canyon sand from 5560-5610. Two zones above need to be squeezed off, plug will be removed or drilled out (one set at 5550'), and the plug from 5338 to 5550 is a sand plug and will also be removed. Plans are to clean out the 5-1/2" casing to 6100' and frac the Getty sand with sufficient gallons and sand for a thorough test of this sand before coming back for a test of the Lower Cherry Canyon. We hope that these two sands can be produced together with sufficient pumping power to remove the water produced.

This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
