Perforate 7972-7974', treat with 500g. 7½% NEFE acid.

Will swab test zones. May pump test zones before testing additional pay.

Perforate 7204-7217', treat with 750g. 7½% NEFE acid. Swab test.

If decision is made to frac, will frac as follows:

Perforations: 5362-5392' w/3000g. 35# linear prepad, 10000g. 35# XL + 22500# 20/40 Ottawa sd.

Perforations: 7204-7217' w/1500g. 35# linear prepad, 5100g. 35# XL + 11800# 20/40 Ottawa sd.

Perforations: 7972-7974' w/1500g. 35# linear prepad, 5100g. 35# XL + 11800# 20/40 Ottawa sd.
