2. Run 5 1/2" production casing to TD as follows:
 - 1 Float shoe
 - 1 5 1/2" 15.5# 8rd J-55 shoe joint.
 - 1 Float collar
 - 21 jts. 15.5# 8rd J-55 casing w/bottom of marker Jt. @ 4305'
 - 1 DV tool bottom @ 4501.
 - 101 jts. 15.5# 8rd J-55 casing w/centralizers run every 175'.
3. Cement in two stages as follows: 1st stage: 150 sx prem. plus Class "C" w/8# Silica + 3# salt + .6% Halad 322, wait 6 hrs. & cement second stage as follows: 760 sx Howco lite w/1# flocele + 200 sx. "C" w/8# Silica + 3# salt + .6% Halad 22, did not circulate, pressure tested to 2000#, Release Rig 5:30 A.M. 1/11/93.
