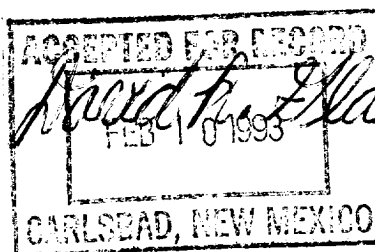

SPECIFIC INSTRUCTIONS
