3. Cement w/100 sx. Hall. Lite + 6#/sx Salt + 1#/sx. flocele & tailed in w/200 sx. Class "C" + CaCl. Plug down @ 11:30 PM 11/12/92. Circulated 143 sx. to pit.
4. Nipple up BOP. pressure up on BOP to 1500# for 30 minutes w/no pressure drop.
5. Began drilling 7 7/8" hole @ 7:30 PM 11/13/92. Drill cement & shoe & pressure up on cement to 500# for 15 minutes w/no pressure drop.
