4. Open DV tool & circulate 5½ hours.
5. Cement 2nd stage w/825 sx. Hall. Lite + ½#/sx. flocele & 3% salt, tailed in w/100 sx. Class "C" Neat, Plug Down @ 3:30 PM 11/22/92.
6. Release WEK Rig #2 @ 8:00 PM 11/22/92.
