Howco cemented w/ 1400 sx Halliburton Lite @ 12.7 ppg followed by 200 sx Class "C" + 5 pps salt @ 14.8 ppg. Plug down @ 0730 hrs CST 3/8/94. Recovered 250 sx excess cement. WOC 24 hrs. ND BOP's and make cut-off. Weld on wellhead and test to 1500 psi. NU BOP's and test to 1500 psi.
