Spudded a 26" hole at 2:00 PM 5-1-94 with Auger Air. Set 40' of 20" conductor pipe. Cemented to surface with ready mix. NOTE: Notified BLM of spud. Resumed drilling a 17-1/2" hole with rotary tools at 4:00 PM 5-2-94.

TD 665'. Ran 16 joints of 13-3/8" 54.5# J-55 (669.74') of casing set at 665'. 1-Texas Pattern notched guide shoe set at 665'. Insert float set at 624.40'. Cemented with 300 sacks Pacesetter Lite "C", 2% CaCl2 and 1/4#/sack celloseal (yield 2.01, weight 12.5). Tailed in with 250 sacks Class "C" Neat 2% CaCl2 (yield 1.33, weight 14.8). PD 6:00 PM 5-3-94. PD 6:00 PM 5-3-94. Bumped plug to 500 psi. Circulated 187 sacks to pit. WOC. Cut off casing and weld on head. Nippled up and tested. Drilled out at 6:00 PM 5-4-94. WOC 24 hours. Reduced hole to 11". Drilled plug and resumed drilling.

This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
