The Lily ALY Federal #2, NM-80645, casinghead gas is measured prior to sales for marketing to GPM by a check point meter. The check point meter is located at the well battery in Unit H (SENE) of Section 3-T24S-R31E. The sales point meter is located at Texaco operated's Texaco Todd Federal #1, located in Unit F (SENE) of Section 2-T24S-R31E. The gas is sold to GPM from the sales point meter. The sales point meter number is 74053.

Yates Petroleum Corporation respectfully requests approval for off-lease measurement of the gas. Calibration tests are conducted periodically on all check point meters. Test results will be provided to the Bureau of Land Management upon request.
