Ran 194 joints of 5-1/2" 17# & 15.5# casing as follows: 15 joints of 5-1/2" 17# S-95/P-110 sandblasted (606.23'); 44 joints of 5-1/2" 17# S-95 varnished (1831.91'); 133 joints of 5-1/2" 15.5# J-55 varnished (5648.80') and 2 joints of 5-1/2" 17# J-55 varnished (83.70') (Total 8170.54') of casing set at 8150'. Float shoe set at 8150'. Float collar set at 8110'. Top of marker set at 7544' and bottom of marker set at 7563'. Cemented with 550 sacks Interfill C and 1/4#/sack flocele (yield 2.61, weight 11.7). Tailed in with 250 sacks Super H, .5% Halad 344, .4% CFR3, 5#/sack gilsonite and 1#/sack salt (yield 1.66, weight 13.0). PD 8:15 PM 5-30-2000. Bumped plug to 1500 psi for 1 minute, OK. WOC. Released rig at 1:15 AM 5-31-2000. NOTE: Displaced casing with fresh water (191 bbls).
