

Spudded a 26" hole with rotary tools at 11:00 AM 5-9-2000. Drilled to 40'. Set 40' of 20" conductor pipe. Cemented to surface. NOTE: Notified Gene Hunt w/BLM-Carlsbad of spud. Resumed drilling a 17-1/2" hole with rotary tools at 5:45 PM 5-10-2000.

TD 538'. Reached TD to run casing at 2:00 AM 5-11-2000. Ran 13 joints of 13-3/8" 48# H-40 ST&C (543.51') of casing set at 538'. 1-Texas Pattern notched guide shoe set at 538'. Insert float set at 498'. Cemented with 275 sacks Halliburton Lite Premium Plus and 1/4#/sack flocele (yield 1.93, weight 12.5). Tailed in with 200 sacks Premium Plus and 2% CaCl2 (yield 1.32, weight 14.8). PD 10:30 AM 5-11-2000. Bumped plug to 360 psi, OK. Circulated 143 sacks. WOC. Cut off and welded on flow nipple. Drilled out at 11:15 AM 5-12-2000. WOC 24 hours and 45 minutes. Reduced hole to 11". Resumed drilling.
