6-17-19-2000 - Cleaned location, set and tested anchors. Moved in and rigged up pulling unit.

6-20-2000 - Nippled up BOP. TIH with 60 joints of tubing. Shut down for night.

6-21-2000 - Finished TIH with remaining tubing and tagged PBTD at 8106'. Loaded hole with 220 bbls 2% KCL water. Shut down for night.

6-22-2000 - TOOH with tubing, bit and scraper. Rigged up wireline. TIH with logging tools and ran GR/CCL log. TOOH with logging tools. TIH with 4" casing guns and perforated 7827-8021' w/22 .42" holes as follows: 7827, 28, 57, 59, 67, 68, 77, 78, 83, 84, 7913, 14, 59, 60, 68, 69, 80, 81, 87, 88, 8020 & 8021' (1 SPF - Delaware). TOOH with casing guns and rigged down wireline. Nippled down BOP. Nippled up frac valve. Shut in. Prep to frac.

6-23-27-2000 - Prep to frac on 6-27-2000.

6-28-2000 - Frac'd perforations 7827-8021' (via 5-1/2" casing) with 96500 gallons 20# borate guar gel, 154865# 20-40 Ottawa sand, 44936# 20-40 resin coated sand & 39419# 16-30 resin coated sand. Shut in 4 hours. Opened well up and began flowing back frac.
