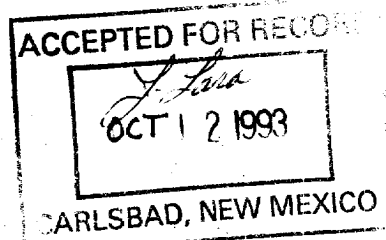

TD 3053'. Ran 68 joints of 8-5/8" 32# J-55 (3055.41') of casing set at 3053'. Float shoe set at 3053'. Float collar set at 3008'. Cemented with 1400 sacks Pacesetter Lite "C", 10#/sack salt, 1/4#/sack celloseal (yield 2.01, weight 12.7). Tailed in with 200 sacks Class "C" 2% CaCl₂ (yield 1.32, weight 14.8). PD 1:55 PM 8-27-93. Bumped plug to 1500 psi, OK. Circulated 148 sacks. WOC. Drilled out at 10:00 AM 8-28-93. WOC 20 hours and 5 minutes. Nipped up and tested to 1000# for 15 minutes. Reduced hole to 7-7/8". Resumed drilling.
