6/30/94: Depth 4210'. RU and ran 97 jts 8-5/8" 32# K-55 ST&C casing and set at 4210'. FC @ 4147'. Cemented w/ 1050 sx "C" Lite containing 9 pps salt & 1/4 pps Celloseal. Tail w/ 200 sx C1 "C" + 2% CaCl₂. Plug down at 11:00 p.m. CST. Circ'd 185 sx to pit. WOC.

7/01/94: WOC. Cut casing off and weld on head. NU & test BOP's to 1500 psi, ok. WOC. Test casing to 1500 psi for 30 min, ok. WOC total of 24 hours. Resume drilling operations.
