Stage tools @ 6499' & 4006'. Float collar @ 8557'. Cmt'd 1st stage w/ 350 sxs "H". Cmt cut short because service company could not maintain proper density. Attempted to circ out cmt. Lost returns after clearing casing w/ cmt and 45 bbls flush. Open tool @ 6499'. Could not circulate. Will do remedial cmt job w/ pulling unit. ND BOP's. Install wellhead. Release rig.
