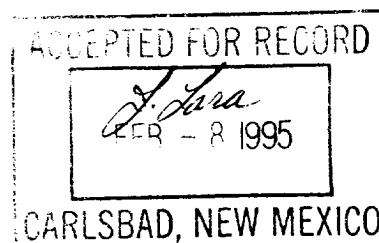

Depth 4195'. RU and ran 94 jts 8-5/8" 32# J-55 ST&C casing and set at 4195'. Cemented w/ 1000 sx "C" Lite containing 9 pps salt and 1/4 pps Celloseal. Tail w/ 200 sx CI "C" + 2% CaCl2. Plug down at 7:00 p.m. MST. Circ'd 75 sx to pit. WOC.

01/13/95:

WOC. Nipple down and cut csg off. Weld on head. NU BOP. PU DC's and TIH. Test BOP and casing to 1500 psi, okay. WOC total of 25 hours. Resume drilling operations.
